Sub: Insurance claim for Loss /Damage to Rice/Paddy Stocks with Custom Millers due to Phailin Storm and floods.

Your honour is aware that due to devastating cyclonic storm "Phailin" followed by incessant rains and floods, there is extensive damage to the plant machinery, godowns as well as to the available stocks of Paddy/Rice and gunny bags in the Rice Mills of the affected districts. In view of this, suitable insurance claims are to be made for the *damages to CMR stocks*.

CMR stocks belonging to Odisha State Civil Supplies Corporation are being insured with nationalized Insurance Companies directly by the Ocscc as mentioned in clause-23 of the Agreement for KMS 2012-13. As such, we have requested all the affected Rice Millers to intimate first hand primary details of loss/damage caused to Paddy, Rice and Gunny bags to the concerned CSO-cum-District Manager immediately. *For convenience of members, a draft format for such intimation is uploaded to our website www.aorma.in for use by members to save time.* A copy is enclosed for your honour's ready reference. This may help in primary assessment of volume of loss for planning inspection by surveyors.

Your honour may kindly appreciate that number of claims will be very high as more than 400 rice mills are in Ganjam district alone out of total 1300 rice mills in our State. Mills in other districts have also affected. As such, top priority is needed for immediate assessment of damage in a planned manner to minimize further deterioration of stocks.

Moreover, most of the *storage godowns have been rendered roofless* and steps are also needed for *immediate acceptance of ready stock of rice* for local consumption at the earliest possible.

We therefore, most humbly request your honour to kindly issue suitable instructions for *1) Immediate acceptance of the available rice stocks for local consumption from the affected mills and 2) arranging early inspection by Insurance Surveyors to enable affected millers to start restoration activities.*
