Sub:

**Payment of Transportation Charges for movement of paddy from
PPC to Mill and of CMR from Mills to depot- approved distance.**

Madam/Sir,

With reference to the subject cited above, I am to say that difficulties in payment of transportation charges for movement of paddy from PPC to Mill and of CMR from mills to deopts has been raised by All Odisha Rice Millers Association. It has been submitted that reimbursement of transportation charges of paddy from Mandi/ PPC to Mills and on Rice from Mills to FCI godown has been made difficult because of lack of joint certification of distance by District Manager, Executive Engineer (R&B) and Executive Engineer (R&D).

To tide over the difficulties, it is decided that Collectors will certify the distance in the following format after collecting same from respective authorities as road from a PPC to a mill or from Mill to a RRC/ FCI depot may be under various authorities like Works, RD, PR, NH etc.

Name of PPCs from where mill is picking up paddy is to be mentioned one after another. Similarly, all depots where mill is delivering CMR needs to be mentioned one after another. The sequence may be as per Society code or Depot Code for PPCs and Depots respectively. The details of distance of PPCs and Depots from one mill are to be completed before a second mill can be taken up.

If you already have the certified distance, you may put it in above format and certify same at the end and provide a copy to FCI local office and keep one copy for record. The above table is to be converted to Excel Sheet and mailed to FS&CW Department and OSCSC Ltd. for record.
