Ref: This office letters of even number dated 31/8/2015 and 16/11/2015.


Sir,

Please refer to the letters under reference towards reimbursement of gunny depreciation of procurement of CMR. The matter has been examined and it has been decided to recover the excess gunny depreciation cost paid to various State Agencies for delivery of CMR during KMS 2010 -11 to 2014 -15 considering the depreciated rate as 19.35% of the new gunny bags excluding transportation charges which has been fixed by Govt. of India in a separate cost sheet during the KMS 2009-10. Therefore, you are directed to recover the excess amount paid on this account as per the provisional costing sheet and intimate the recovery position to Regional Office on weekly basis.

Since Govt. of India has calculated the gunny depreciation for new gunny in the costing sheet of CMR for the KMS 2015-16 with a foot note that in case State proposes to use once used/old gunny bags, then they should submit separate proposal for fixation of rate for these gunnies. The gunny depreciation rate during KMS 2015-16 will be released on receipt of separate cost sheet from Govt. of India for use of once used/old gunny by the procuring agencies in the State during KMS 2015-16.


