Sub: Assessment of marketable surplus of farmers registered with societies level.

Madam/Sir,

I am to say that Para-3.1 of Food and Procurement Policy for the KMS 2015-16 provides that Society wise Farmers Paddy Assessment & Procurement Register would be generated on the basis of marketable surplus (after deducting quantity required for consumption @ 3 quintals per family member) in respect of each registered farmer.

However, there has been less rainfall this year which has affected crops in over 50% Blocks and there is likelihood of adverse impact on procurement of rice to meet our PDS needs and Central ~~Pool~~ commitments of 30 lakh MT of rice.

Government has therefore been pleased to waive out the stipulation of deducting quantity as aforesaid for determination of marketable surplus of farmers for the current KMS 2015-16.

The Farmer Registration Module has accordingly been modified to give effect to the order of Government.
