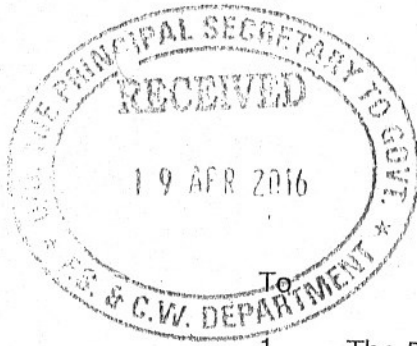

Subject: Fixation of Provisional rates of Custom Milled Rice (CMR) for KMS 2015-16 - Clarification regarding once-used gunny in procurement of paddy

Madam/Sir,

I am directed to say that during Kharif Marketing Season (KMS) 2015-16, the following note regarding gunny bags was included in the letters fixing the provisional rates of Custom Milled Rice (CMR):

"Note (i) This costing is for new gunny bags only. In case procurement of paddy is done in once-used gunnies, cost will be approved separately for such bags on receipt of a proposal from the State Government."

2. In this regard, it is clarified that the policy of once-used gunny bags, payment of gunny depreciation has already been laid down in F.No.15(2)/2013-Py.III dated 24.05.2013 of this Department, which has been further amended vide F.No.15(8)/2004-Py.III (Pt.) dated 04.02.2016. Therefore, as such, no separate proposal is required to be submitted by the State Government for approval of rate of once used gunnies and it has been decided to amend the provisional cost sheets already issued for various States for KMS 2015-16 and the words "in case procurement of Paddy is done in once used gunnies, cost will be approved separately for such bags on receipt of a proposal from the State Government" shall stand deleted in the above said note.

3. In case State uses other than once-used old gunny bags, then only State Government has to obtain prior approval from Government of India for using such gunny bags and also seek approval of rate for the same for getting the cost of such gunnies reimbursed from FCI.

4. The note (i) in the provisional cost sheets issued for KMS 2015-16 stands revised to the above extent.

5. This issues with the approval of the Competent Authority.
