Sub: Release of Market Fees to RMC on Procurement of paddy by OSCSC.

Ref: Notification No. 1881 dt.4th Feb, 2008 of Cooperation Department enhancing Market Fees from 1% to 2%.

Sir,


You are aware that Odisha State Civil Supplies Corporation is procuring paddy from the farmers under DCP Scheme of GoI since KMS 2003-04 and depositing RMC fees as per rates provided under Section 11 of the Odisha Agricultural Product Markets (OPAM) Act, 1956. The Market fees on paddy has been enhanced from 1% to 2% on paddy vide Notification No.1881 dt.4th Feb, 2008 of Cooperation Deptt., Govt. of Odisha. As per the said Notification, the additional resources generated shall be utilized only by way of Capital expenditure for strengthening/ creation of required infrastructure and for purchase of equipments for paddy procurement.

The market fees which is one of the incidentals in the cost sheet issued by GoI deposited by OSCSC is reimbursed by GoI as subsidy. OSCSC is required to submit its accounts for each KMS to GoI for finalization of Provisional Costing and as per guidelines issued by GoI, an Utilisation Certificate for the RMC fees paid for previous KMS is to be submitted for each KMS, alongiwht KMS Accounts. OSCSC has vide this office letter No. 14895 dt. 19.08.2016 requested Odisha State Agricultural Marketing Board for issue of Utilisation Certificate. Copy of the letter is enclosed. But there is no response till date.

It is requested to impress upon appropriate authority to issue Utilisation Certificate KMS wise from from KMS 2005-06 onwards for submission to GoI & finalization of costing. Unless such Certificate is furnished, it is apprehended that reimbursement of Market Fees may be kept withheld by GoI.
