
With reference to the subject & letters cited above, I am to say that as per decision taken in the meeting held on dt.22.06.2017 in the chamber of Principal Secretary, FS&CW Deptt. the revised rates of transportation charges on paddy & handling charges on CMR delivered in RRC for KMS 2015-16 is applicable for the CMR delivered till 31.12.2016 . Accordingly transportation charges on paddy and handling charges on CMR for KMS 2015-16 shall be released to the custom millers as per the revised rates as detailed below.

- 1. Transportation charges on paddy :-** Transportation charges on paddy shall be released to the custom millers at the revised rates communicated vide letter No. 19205 dt. 8.11.2016 for the CMR delivered upto 31.12.2016. Transportation charges on paddy for the CMR delivered after 31.12.216 shall be paid at pre-revised rates i.e. rates finalized for KMS 2014-15.
- 2. Handling charges on CMR delivered at RRC:-** Handling charges shall be paid at the revised rates for the quantity of CMR delivered in RRC till 31.12.2016 which is the extended date allowed by GoI for procurement of rice. CMR delivered after 31.12.216 shall be paid at pre-revised rates i.e. rates finalized for KMS 2014-15.

3. Handling charges on rice delivered at FCI, Custody & Maintenance Charges, Insurance Premium :- The revised rates as communicated vide letter No. 19205 dt. 8.11.2016 shall be applicable for the custom millers who have delivered entire CMR by 30.09.2016. Other millers shall be paid at the rates finalized for KMS 2014-15
