Sub: Representations for extension of *timeline for delivery of CMR (Kharif crop) during KMS 2017-18.*

Madam/ Sir,

I am to say that for current Kharif, you have been informed that the deadline for delivery of resultant rice of paddy(Kharif crop) would be 30.4.2018 vide this Department letter No. 388 dated 5.1.2018.

Meanwhile, representations/ requests have been received from All Odisha Rice Millers' Association as well as several Collectors to extend this deadline in respect of late procuring districts.

Such requests are being looked into by the Department and this Department is seized of the issue. A decision in this regard would shortly be communicated relaxing the deadline for delivery of CMR of Kharif crop.

There should be no fear on the part of the custom millers regarding their potential failure to stick to the deadline for rice delivery and, on that ground, to go slow on procurement.

You are therefore requested to carry on Kharif procurement operations and ensure that no paddy which arrives in PPCs remains unprocured and no farmers is left to any difficulties in view of miller's apprehension regarding timeline for rice delivery.

This may be brought to the notice of all concerned.


