**Sub: Rates of different Procurement Incidentals to be paid to the Custom Millers for KMS 2017-18.**

**Ref: This office letter No. 4507 Dt.15.03.2018.**

Sir,


In inviting a reference to the subject stated above, I am to say that it has been decided in the 181<sup>st</sup> Board of Directors Meeting held on 28.03.2018, to allow different procurement incidentals as per the rates indicated below for the services rendered by them in KMS 2017-18 .

1. Transportation Charges on paddy:- @ Rs.18.00 per quintal of paddy for 1<sup>st</sup> 10 KMs flat. For subsequent distances from 11 KMs to 40 kms @ Rs.0.50 per quintal per km and for distance beyond 40 kms @ Rs.0.40 per quintal per km. However where the total distance from mandi to mills is beyond 100 kms transportation charges shall be paid @ Rs.0.40 per quintal per km from 11th kms onwards . The transportation charges on paddy for lifting of stock from other districts shall be allowed at the same rate and same principle as was allowed in KMS 2016-17.
2. Transportation Charges on Rice:- @ Rs.15.00 per quintal of rice for 1<sup>st</sup> 10 kms flat. For subsequent distances from 11 KMs to 40 kms @ Rs.0.50 per quintal per km and for distances beyond 40 kms @ Rs.0.40 per quintal per km.
3. Milling Charges :- i) @ Rs.20.00 per quintal of paddy for milling of parboiled rice  
ii) @ Rs.10.00 per quintal of paddy for milling of raw rice.
4. Mandi Labour charges :- @ Rs.3.50 per quintal of paddy.
5. Handling charges on delivery of CMR at FCI:- Rs.6.00 (Rupees six) per quintal of rice.

6. Gunny Usages Charges :- Rs.12.66 per quintal /Rs.12.30 per quintal of common raw rice/common parboiled rice .
7. Custody & maintenance charges is being paid to the custom millers after complete delivery of CMR . The rates of custody & maintenance charges will be communicated separately.
8. The custom millers who delivers CMR due of KMS 2017-18 within the due date as prescribed by Govt. in FS&CW Deptt. shall be allowed at revised rates of transportation on paddy i.e. Rs.18.00 per quintal for 1<sup>st</sup> 10 kms and handling charges of CMR on delivery at FCI @ Rs.6.00 per quintal. Other millers will be allowed transportation charges @ Rs.15.00 per quintal on paddy for 1<sup>st</sup> 10 kms and handling charges @ Rs.5.00 per quintal of CMR delivered at FCI

The above instructions supersede the earlier instructions issued vide this office letter No.4507 dt.15.3.2018.




