Sub: - Guidelines for Rabi paddy procurement for the KMS: 2017-18.

Ref: - This Office letter No.199/MD dt.28.04.2018 and No.203/MD dt.30.04.2018..

Sir,

I am to say that modalities for selection of custom millers to participate in Rabi procurement of KMS: 2017-18 have been communicated vide this Office letters under reference to all Rabi paddy procuring districts.

In addition the below mentioned issues and modalities shall be followed for smooth Rabi paddy procurement of KMS: 2017-18.

- 1) Apart from security deposit, Post Dated Cheques (PDCs) shall be obtained from the Millers for the value of paddy delivered beyond security deposit as per the detailed procedure communicated for Kharif season of KMS: 2017-18.
- 2) Delivery of paddy to the Millers should be made through MAS i.e. as per security deposit, milling capacity and CMR delivered with reference to Kharif paddy.
- 3) Raw Rice Mills in boiled rice consuming districts and vice versa shall not be allowed to participate in Rabi procurement.
- 4) No Raw Rice Mills in any district shall be allowed to participate in Rabi paddy procurement as the Rabi paddy is not suitable for production of FAQ raw rice and the out turn ratio of 67% CMR is also not achievable.
- 5) The Millers of all districts shall complete delivery of CMR both of Kharif and Rabi by 31.08.2018.
- 6) The districts where only Kharif paddy has been procured the entire delivery of CMR shall be done by the Millers by 31st July, 2018 positively.
- 7) Other district millers when deputed to procuring districts shall be qualified after 100% delivery of CMR of their own district as well as of other district, if availed, during the Kharif 2017-18. Such Millers shall be allowed participation in other district on 1:6 security deposit norm and deployment shall be made as per the provision of Operational Guidelines for KMS: 2017-18.

The above guidelines shall be followed scrupulously.
