**Sub: Rates of different Procurement Incidentals to be paid to the Custom Millers for KMS 2015-16, KMS 2016-17 & KM S2017-18**

Sir,

In inviting a reference to the subject stated above, I am directed to say that it has been decided in the Meeting held on 24.05.2018 with the All Odisha Rice Millers Association , to allow following procurement incidentals as per the rates indicated below for the services rendered by them in KMS 2015-16, KMS 2016-17 & KMS 2017-18 .

1. For KMS 2015-16 :-

i) Gunny Depreciation:- Gunny depreciation @ Rs.17.47 per quintal of rice is due to the millers. At this rate FCI has settled the bills of OSCSC for KMS 2015-16. Since millers have already been paid Rs.17.00 p.q. the balance of Rs.0.47 per quintal of rice shall be paid to them.

ii) Handling Charges on CMR delivered to FCI :- The revised rate of handling charges @ Rs.6/- per quintal shall be paid for the quantities of rice delivered to FCI up to 30.9.2016 only to those millers who returned 100% CMR by the enhanced date line i.e. by 31.12.2016 and for the quantity delivered after 30.9.2016 shall be paid at pre-revised rate i.e. Rs.5/- p.q. to these millers. Other millers i.e. the millers who completed delivery after 31.12.2016 shall be paid at pre-revised rate i.e Rs.5/- per quintal of rice.

2. For KMS 2016-17 :-

1) Release of revised rates of transportation on paddy for KMS 2016-17:- District Millers Association is to represent to the Managing Director , OSCSC for allowing revised rates to the millers who could not deliver the entire CMR by the date line of 30.9.2017 due to godown constraint . The representation of District Millers Association would be examined by a committee constituted for the purpose on case to case basis and the exercise shall be completed in a period of one month.

3. For KMS 2017-18 :-

Revised Mandi labour charges for KMS 2017-18:- The millers shall be paid mandi labour charges @ Rs.4.65 per quintal of paddy for handling operation at mandi during procurement of paddy from farmers for KMS 2017-18 instead of Rs.3.50 p.q. communicated vide letter No. 5658. dt. 2.4.18
