Sub: - Regarding rules & regulation of security deposit norm for participation of Custom Millers in Rabi paddy procurement of KMS: 2017-18.

Ref: - This Office letter No.199/MD dt.28.04.2018, No.204 (MD) dtd.30.04.18 & FS & CW Department memo No.10813 dt.23.05.2018.

Sir,

I am to say that criteria for selection of Custom Millers to participate in Rabi procurement of KMS: 2017-18 has been communicated vide this Office letter under reference. Custom Millers who have delivered 100% /50% as the case may be by the stipulated date shall be allowed to participate in Rabi procurement under relaxed security deposit norm i.e. at 1:6 ratio.

It has come to the notice that the Millers who were under 100% security norm for Kharif procurement due to delayed delivery of 100% CMR due of KMS: 2016-17 have been allowed to participate on 1:6 security norm for Rabi procurement as they have delivered 100% /50% of Kharif CMR due as on 30.04.2018.

It is felt necessary that the Millers who were under 100% security deposit norm against Kharif procurement shall not be given benefit to lift Rabi paddy in the same KMS at 1:6 security deposit norm although they have delivered 100% /50% of CMR due out of Kharif procurement of KMS: 2017-18.

Accordingly following decision has been taken at Government level.

- 1) The Millers who were under 100% security deposit norms during Kharif procurement of KMS: 2017-18 shall not be allowed to participate in Rabi procurement on 6 times security norms. They shall lift paddy at 1:1 security deposit norms for the current Rabi season.
- 2) Decision will be taken on revision of security deposit norm in coming KMS basing on their performance in delivery of CMR of KMS: 2017-18.
- 3) Deviation, if any, in allowing such Millers to participate in Rabi procurement at 1:6 security deposit norm shall not be allowed.


You are therefore requested to follow the above procedures while allowing the Millers to participate in Rabi procurement and action taken in the matter may be intimated to Government as well as this Office forthwith.
