

Ministry of Agriculture and Farmers Welfare (MOA&FW), Govt. of India have signed a protocol with General Administration of Customs of the People's Republic of China (GACC) in respect of export of Indian rice (Basmati and non-Basmati) to China. The protocol is to ensure that rice exported from India meets the Phyto-Sanitary concerns of China.

2. The rice processing unit are required to be registered by the Directorate of Plant Protection, Quarantine and Storage (DPPQ&S), MOA&FW, Govt. of India. The registered mill will be inspected by Chinese authorities for approval for export of rice from India to China.

3. It is requested that rice processing units in the state, interested in export of rice (Basmati and non Basmati) to China, may be advised to submit application to DPPQ&S address to Dr. K.S. Kapoor, Joint Director, Email: dr.kskapoor@gov.in . The list of 17 rice manufacturers from Odisha registered as member/exporter with APEDA is attached.

4. Information about online payment of fee of Rs. 5000 alongwith the application is attached. The SOP for registration of rice units is available at <http://plantquarantineindia.nic.in/PQISPub/pdf/sopexpchina2015.pdf>
Annexure 1 of the SOP prescribes the application form

The team from GACC is visiting India from July 9-17, 2018 for inspection of rice units already registered with DPPQ&S. Therefore, mills interested for export of rice to China may be advise to apply to DPPQ&S immediately / by tomorrow to facilitate pre-inspection by them before visit of the Chinese team.
