Sub: Release of procurement incidentals to the custom millers for the KMS 2018-19.

Sir,

Inviting a reference to the subject cited above, I am to say that the provisional economic costing of CMR for DCP and Central Pool have been communicated by GoI for KMS 2018-19. Based on the rates provided in the PCS and the rates allowed in the previous KMS, it has been decided to allow following incidentals as per the rates mentioned to the custom millers participated in Procurement operations for KMS 2018-19.

1. Milling Charges: Rs.20.00/ Rs.10.00 p.q. of paddy milled for delivery of Common Boiled Rice/ Common Raw Rice.
2. Gunny Usage Charges: Rs.14.05/ Rs.14.49 p.q. of Common Boiled Rice/ Common Raw Rice. The gunny usage charges is paid to the custom millers for use of two old jute bags and two new gunny bags for packing of paddy required for one quintal of rice. The custom millers shall submit following documents/ statements along with their claims for gunny usage charges.
 - a) Monthly Stock Account of old gunny bags in the format as communicated vide letter No.438 dt.09.01.2019 of OSCSC Head Office.
 - b) Declaration that old gunny bags purchased is being only once after purchased.
 - c) Supporting documents on purchase of old gunny bags as per instructions issued vide this office letter No.16867 dt.25.10.2018.

In this office letter No.438 dt.09.01.2019 it was instructed to all the District Managers to collect old gunny account for the KMS 2017-18 from the custom millers and to send consolidated statement of gunny account to Head Office by 31.01.2019. Gunny usage charges for KMS 2018-19 may only be released to the millers who have furnished the gunny account of 2017-18 as per the format.

3. Transportation Charges on paddy and rice: It has been decided for adhoc payment of transportation charges @ Rs.22.50 p.q. of paddy for transportation of paddy from PPC to mills and @ Rs.18.75 per quintal of rice for delivery of rice at RRC/FSD both for 1st 10 kms, to the custom millers for KMS 2018-19. The rates of transportation for distance covered beyond 10 kms, mandi handling charges, custody & maintenance charges and handling charges on CMR will be communicated later.

The above incidentals shall be paid for the quantity of rice delivered by the miller at RRC/FCI.
