Sub:- Color coding and branding of new gunny bags to facilitate identification of crop year of stock for KMS 2019-20.

Ref :- Govt. of India letter No.15(I)/2012-PY.III(E.F.318639) dt.08.05.2019.

Sir,

I am to say that Govt. of India in Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution in letter No.15(I)/2012-Py.III (E.File.318639) dt.08.05.2019 (copy enclosed) has directed to adopt "**BLUE**" color coding for new gunny bags for next KMS 2019-20. The details are as given below.

1. Stencil or Branding as per indenters' requirement is done in "**BLUE**" color.
2. Marking or stitching on the mouth of the bag after filling the grain is done by the FCI/State Agencies in "**BLUE**" color.
3. For identification marking of marketing season, the jute bag carries Color Coded strip/s. Width of each strip is of 4 threads. Each strip runs along the length of the Bag and is in "**BLUE**" color.

4. For bags to be supplied through Jute Commissioner of India.

- (i) Single strip is to be printed for bags to be supplied through the Jute Commissioner of India. This single strip is printed at a distance of about 150 mm away from any selvedge of the bag.
- (ii) For supply of jute bags to Andhra Pradesh, Telangana, Tamil Nadu, Kerala and Karnataka through Jute Commissioner of India, an additional Black color strip will be printed on each bags at a distance of about 150 mm away from other selvedge of the bag.

5. For bags not purchased through Jute Commissioner of India

For jute bags not purchased through Jute Commissioner of India, two strips are printed on each bag. Each of two strips are printed at a distance of about 150 mm away from the respective selvages of each bag.

Presently new gunnies supplied to your Districts is for KMS 2018-19 which shall close on 30.09.19. The above color coding relates to KMS 2019-20, which will commence from 01.10.2019.

6. You are directed to ensure that the above details of color coding, branding etc are circulated to all RRCs I/c and others concerned for necessary verification & confirmation of the color coding, branding & other details in respect of new gunnies to be used in ensuing KMS 2019-20.
