Sir,

With reference to the letter on the subject cited above, it has already been decided to close the small and unscientific godowns (500 MT & lesser capacity) of OSCSC being utilised in your district. But it is observed that some small godowns of above criteria are still in operation in certain districts.

Hence, you are hereby directed to close such small and unscientific godowns as per the list attached in Annexure-A with immediate effect. You are further directed to carry out the following instructions.

- (i) No further DC shall be issued against the above small and unscientific godowns henceforth and no further stock shall be received in such godowns after receipt of this letter.
- (ii) All available stock shall be liquidated from these godowns under PDS by ensuring nil storage capacity of the godowns.

Any deviation in carrying out above instructions shall be seriously viewed. Action taken in the matter may be intimated to the undersigned.
