Sub: Request for release of amount with-held for FCI Delivery.

This is to bring to your kind notice that an amount of Rs.2,46,890/- had been kept withheld from our bills in respect of delivery of your CMR to FCI during KMS 2011-12. We had delivered Q.8,369.61 during Dec,11 to Mar,12 and Q.3,779.67 during April,12 to Sept,12 to FCI.

You may kindly appreciate that non-refund of with-held amount even after more than one year is really very painful and *it is not possible on the part of the miller to remain deprived from his legitimate dues for unspecified period.* A system has to be developed to ensure timely payment to the miller. *Moreover, determination of probable rebate for deduction from bills, if any can be easily ascertained from the Rice Delivery Acceptance Notes issued by the concerned Purchase Officer of FCI at the time of delivery of stock.* This practice is prevalent in some districts while some districts do not deduct any amount from the bills of miller. There is no point in waiting for the FCI to deduct. Even if the amount is deducted, it will be hardly possible on your part to get the requisite information from FCI.

We therefore, request you to kindly arrange refund of with-held amount after deduction of rebate, if any without any further delay and oblige.
