Sub:- Supply of New B.Twill gunny bags as per supply orders of DGS&D against March'2014 KMS 2013-14.

Sir,

In continuation to this office letter number 5606 dt.22.03.2014 I am to say that as per supply order issued by DGS&D for supply of new gunny bales for the KMS 2013-14, Sri Bibhuti Charan Rout, PI, Sri Nirmal Mandal, PI, & Sri Himansu Biswal , PI of this office are here by deputed to Kolkata for inspecting the quality and weighthment of new B.Twill gunny bags at each jute mill point for dispatching the same through our transporter M/s Sahoo & Sahoo Transport, Chauliaganj,

Cuttack engaged for the purpose. They are directed to do the following during their stay at Kolkata :-

- i. They will make contact with all the jute mills about their readiness in dispatching gunny bales.
- ii. If the gunny bales are found ready after quality inspection then they shall visit concerned jute mills to verify the quality and weightment of gunny bags before dispatch of the same.
- iii. They shall ensure that after loading of the gunny bales all the loaded vehicles are weighed in the jute mill and net weight of the loaded gunny bales are duly recorded in the transportation challan / way bill etc.
- iv. They shall accept the stock which conform to the standard, texture and weightment fixed by DGS&D. They shall furnish their inspection report to this office. Bales not conforming to standard , weight and texture shall not be accepted and lifted from the jute mill.

Accordingly the above jute mills are requested to ensure the above for smooth and timely lifting at the stock .

- v. Sri B.C.Rout, PI will make e-way bill online and sign the CRC.

As gunny bales are urgently required for packing of CMR immediate steps may be taken for dispatching 3044 bales in the 2nd phase to different destinations as noted below :-

He is also directed to ensure that the loaded truck his weighed and correct net weighment of the stock i.e. (weight of loaded truck - tare weight) is properly mentioned in the transit chalan and the weight of the gunny bales should conformed to the standard weight fixed by DGS&D.
