OSCSC Ltd.Sub: **Scientific storage of paddy by the custom millers – Disposal of CAP cover: reg.**Ref: (1) OSCSC letter no.3642 dt.22.02.14.
(2) OSCSC letter no.5771 dt.25.03.15.

Sir,

With reference to the subject cited above, I am to say that instruction was issued to deliver paddy to the custom millers within security deposit norms. In case of possibility of violation of security deposit norms paddy purchased from farmers to be stored under CAP storage project. Besides, it was also instructed to ensure scientific storage of paddy at the miller's level utilising CAP cover supplied by OSCSC on payment of cost. This was also discussed and decided in the last CSO's conference held on 6 & 7th April'2015.

On review it is revealed that except Nayagarh none of the districts has started disposing CAP covers to the millers and it is unfortunate to note that CSO, Sambalpur & Gajapati have requested to transfer the CAP covers from their districts inspite of instruction for issue to their millers.

It is worth mentioning here that due to unscientific storage of paddy at miller's level, the resultant rice turn to be discoloured and not merchantable. 1250 CAP covers stored in 08 districts have been allotted in favour of 16 districts. Other districts can also obtain the required CAP cover from nearby districts.

In view of above, it is once again instructed to dispose off the CAP cover to the millers before onset of monsoon on payment of Rs.9917.59 per cover in order to ensure scientific storage of paddy during storage at miller's level, otherwise you will be held responsible not only for violation of security deposit norms but also for delivery of substandard rice by the millers in your district.

Action taken for disposal of CAP cover to the millers may be reported by 15th June'2015 for further action in this matter.

This may be treated as "EXTREMELY URGENT".
