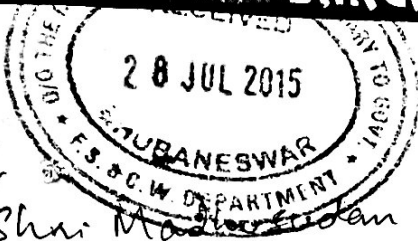
In view of this, you are therefore requested to kindly look into the matter and offer your views with inputs for taking further action at this end.

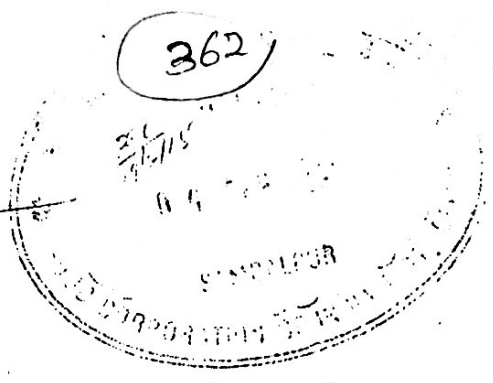
