Sub: - Finalization of Transportation Charges for CMR delivered by State Govt. /Agencies to FCI and transportation of paddy for CMR and FCI paddy & CMR for Central Pool in KMS 2014-15 & 2015-16 - reg.

Sir,

With reference to above, approval is hereby conveyed for payment of transportation charges to the various State procuring agencies for delivery of CMR/transportation of paddy to produce CMR and transportation of FCI paddy for delivery of CMR to FCI by the millers during 2014-15 & 2015-16. The details of slab rates are appended below.

Distance Slab	Rate
0-10 KMs (For entire distance)	Rs. 12. 50 per Qtl.
11-40 KMs	Rs. 0.50 per Qtl. Per KM.
41 KMs onwards and Maximum up to 100 KMs	Rs. 0.40 per Qtl. Per KM.

The above transportation charge is applicable for transportation of paddy from purchase centres/mandi to mills and for rice from mills to storage godowns.

The same rate is payable for CMR by FCI and CMR delivered by State Govt. /Agencies to FCI for Central Pool subject to following terms and conditions.

1. These payments may be deemed to be provisional. An undertaking has to be taken from the State Govt. Agencies/Millers that they will finally abide by and accept the transportation rates as and when finalized and fixed by Tariff Commission to avoid any audit objections in future and in case of any excess payment they will refund the same.
2. The payment of transportation charges shall be subject to the condition that the State Government/Agencies/Millers shall furnish a certificate to the effect that the transportation charges claimed on the actual distances covered in transportation.
3. Payment for distance beyond 40 KMs shall only be made where no godowns are available within 40 KMs on proper verification.
4. It should be ensured that the transportation is restricted to minimum necessary distance.
5. The purchase centre/ mandi and the mill need to be distinct and separate so as to require any transportation.
6. The payment of transportation charges may be subject to the condition that the State Govt. Agencies/Millers have to furnish a certificate regarding actual distance covered in the transportation from the appropriate authority. Before releasing the payment it has to be checked and verified by FCI invariably.
