**Proceedings of the weekly paddy procurement review meeting
held on 04.03.2013 at 3.30 PM in the Conference Hall of the
F.S & C.W. Department**

The weekly paddy procurement review meeting was held under the Chairmanship of Commissioner-cum-Secretary, F.S & C.W. Department on 4th March, 2013 at 3.30 P.M. in the Conference Hall of F.S & C.W. Department. The following members were present in the meeting.

1) CMR of 2011-12 KMS

The delivery of CMR for the KMS 2011-12 made by different Procuring Agencies was reviewed. The following Agencies have delivered CMR as given below:-

Against the total CMR due of 29.03 lakh MT, FCI has received 7.44 Lakh MT of CMR and OSCSC has received 2129630 MT making a total receipt of 2869656 MT. This leaves a balance of about 36268 MT of rice to be received from the Millers in several districts. The pendency of CMR in the following 9 districts is high.

1. Bargarh 1967 MT
2. Balasore 10564 MT
3. Bhadrak 8906 MT
4. Sambalpur 4225 MT
5. Sonapur 1208 MT
6. Khurda 3177 MT
7. Jagatsinghpur 1560 MT
8. Kalahandi 1844 MT
9. Cuttack 1009 MT

As two districts of Bhadrak and Baleswar together have more than 19000 MT each pending CMR of KMS 2011-12, M.D. needs to give more lifting programme from these two districts for Mayurbhanj and Keonjhar so that all the CMR is received by 31.03.2013 positively. Lifting program for March for 4500 MT from Baleswar &

3920 MT from Bhadrak has been given by OSCSC. It needs to be liquidated in the next program.

2. Review on Procurement of paddy and delivery of rice for KMS 2012-13

The review of procurement of paddy and delivery of rice by different Agencies for the KMS 2012-13 was made. On review it was found that as on 04.03.2013, 3793922 MT of paddy has been procured.

The following table shows the Agency wise procurement of paddy and delivery of rice as on 04.03.2013.

It is seen that paddy procured this year (date on date) is 50% more than that of last KMS where as the CMR delivery is just about the same. This means we need to speed up rice delivery so that surplus procurement can be evacuated to outside the state on a regular basis by FCI.

It was further decided that MARKFED, TDCC & NAFED will ensure delivery of 15,000 MT, 10,000 MT & 2,000 MT of CMR in March, 2013. Besides, all Collectors will be informed to ensure delivery of total quantity of available CMR with them for effective utilisation of FCI godown.

4. Evacuation by FCI

The following table shows the month-wise Inflow/Evacuation of CMR by FCI for KMS 2012-13.

The D.G.M., FCI informed that 30000 MT of CMR has been programmed for evacuation outside the State in March, 2013. The DGM, FCI further informed 70,000 MT of wheat will be inducted in March, 2013.

The DGM, FCI requested for utilisation of following rice stock of three FCI depots – Badampahar 2800 MT, Keonjhar 2400 MT & Phulbani 7000 MT as these belongs to KMS 2011-12 on priority. Chairman requested MD, OSCSC to do the needful. The low evacuation plan is mainly because of low rice stock availability in FCI depots.

5. Payment of dues by FCI

M.D., OSCSC informed that dues to the extent of Rs.90.00 crore is pending with FCI for payment to OSCSC for the year 2011-12 and an amount of 70.42 Crore is pending for the year 2010-11. The G.M. FCI was impressed upon to look into the matter personally and expedite payment of outstanding dues of OSCSC Ltd. & MARKFED expeditiously.


6. Demands of Millers Association

Discussion was made on release of adhoc payment @ Rs.70/- for two pieces of gunny bags per quintal of rice to the millers pending receipt of final rate of gunny bags since OSCSC is not able to supply adequate quantity of gunny bags & millers

are reluctant to arrange gunny bags of their own apprehending late payment which may affect timely delivery of CMR.

After discussion it was decided that OSCSC will arrange adhoc payment @ Rs. 70/- for two pieces of gunny bags & the balance amount will be paid after receipt of final cost of gunny bag from Govt. of India.

The meeting ended with a vote of thanks to Chair & to all participants.
