Sir,

We the following Rice Millers of Balasore District beg to draw the following few lines for favour of your kind consideration and sympathetic order.

- That, We the 33 Miller Agents of Balasore District has participated in Paddy procurement in Balasore District.
- That, Balasore District has procured 1, 47,139.825 M.T Common FAQ Paddy during K.M.S-2012-13 under OSCSC Ltd Account.
- That, the resultant Custom Milled rice to be delivered by the Miller Agent under OSCSC Ltd Account is 1,00,055.081 M.T.
- 4. That, as per the Govt. in F.S & C.W Department letter Balasore district is to be delivered 50% of the C.M.R to F.C.I under OSCSC Ltd Accounts, which comes to 50,027.540 M.T. and same quantity to RRC under OSCSC Ltd, Balasore.
- That, till date we the Millers of Balasore District have delivered 14,579.331 M.T and 24,856.818 M.T to FCI and RRC under OSCSC Ltd respectively, totalling to 39436.149 M.T.
- That, the Balance C.M.R to be delivered to FCI and RRC under OSCSC Ltd is 35,448.210 M.T and 25,170.720 M.T respectively, totalling to 60,618.930 M.T.
- That, K.M.S-2012-13 is going to end on 30.09.2013.
- 8. That, the F.C.I, Balasore giving programme for delivery of C.M.R is only 15 Lots in each F.S.D under F.C.I. i.e. at Ranital, CWC, Balasore, Rupsa and Jaleswar, totalling to 30 to 40 Lots for a day.
- 9. That, in Ranital about 30 Millers from Bhadrak District and 8 Miller from Balasore District has been tagged. So the allotment for delivery of C.M.R in a day for Balasore District is less than one lot. Further F.C.I giving only 3 days in a week for delivery of C.M.R.
- 10. That, in F.S.D, Rupsa the Miller of Mayurbhanj are also tagged and the Purchase Officer intentionally harassing the Miller and denied to receive the C.M.R.

- 11. That, if we took all the above aspect in to account the programme given by the FCI authority for Balasore District is about 30 to 40 Lots per day i.e. 90 to 120 Lots for a week, which comes to about 2,430.000 M.T. and in a month about 9,720.000 M.T.
- 12. That, if we will deliver in the above trend it will took 4 to 5 month for delivery of the total C.M.R.
- 13. Further, we the Millers bring to your kind notice that, FCI authorities are harassing in deliver of C.M.R and intentionally returning the C.M.R. In this contest it may be pointed out that, even if FCI authorities are giving programme, but taking the plea of rain they are returning the C.M.R. and in some time they are not giving programme in the plea that they have no shed for unloading the C.M.R.
- 14. That, due to the above fact we the Millers are bound to stop milling & due to poor programming of FCI the quality of milled CMR degrades and it is not possible in our part to deliver the total C.M.R in time.
- 15. That, the Godown Capacity under OSCSC Ltd of Balasore District is about 15000 M.T. and most of the godowns are lying vacant.
- 16. That, the monthly requirement of rice in P.D.S for Balasore District is about 9,000.000 M.T and the D.M.OSCSC Ltd, Balasore is requisiting C.M.R from other district like Bhadrak and Jajpur District though we have sufficient C.M.R for delivery.
- Further, during the K.M.S 2011-12, OSCSC BLS has purchased 21000.000 M.T. paddy & FC! % of delivery of CMR is 20%. But during the current K.M.S OSCSC has procured 14000.000 M.T. & FC! % of delivery is 50%.

Therefore, we are requesting your honour to reduce the deliver percentage to FCI from 50% to 10 - 15 % and stop movement of C.M.R from other district to Balasore so that it will be possible in our part to deliver 100% C.M.R in time and our milling capacity will be fully utilized.
