Sir,


Respectfully with ref. to our previous letter dated 06.03.14 we once again bring to your kind notice that a huge amount of Rs. 4,75,385/- has been deducted from our final custom milled Bill for the last Kharif year 2012-13 without any fault. In this regard we have also put forth our appeals in writing and requested the A/c. Section personally to revise the bills as we have no fault on the ground which they have withheld such a heavy amount, but no response is found yet.

Sir, we also bring to your notice that as per the norms the delivery of CMR dues was made within stipulated time. So the delivery of rice was never delayed beyond 120 days from the date of release of paddy from the joint custody and maintenance for the last Kharif year 2012-13. So we assume that they might have done it with some misunderstanding as there is no valid ground to deduct / withheld such a heavy amount from our bill.

Although our FCI dues have been diverted to RRC, those stocks have also been delivered intime or within time limit i.e within 120 days. In this regard we have also vividly described in our letters why the FCI stocks could not be delivered at FCI Ranital, the xerox copies of the same letters are enclosed herewith for your kind information.

Therefore, you are requested to look into the matter and do the needful in releasing the withheld amount deducted from our Bill and oblige.
