

Commodity	Variety	Minimum Support Price for 2014-15 season (Rs. per quintal)
Paddy	Common	1360
	Grade A	1400
Jowar	Hybrid	1530
	Maldandi	1550
Bajra	-	1250
Maize	-	1310
Ragi	-	1550

2. It is requested that wide publicity may be given to the above MSPs fixed by the Department of Agriculture & Cooperation for procurement in KMS 2014-15 so that farmers are well informed about MSP announced in the States concerned and their participation in MSP programme is ensured.
