
The above rate of unloading is quite high from any standard. The monopolistic attitude of labourers is spreading fast and needs to be curbed.

Sub :- Grievance of Sonepur District Millers Association.

Sir,

We the Millers of Sonepur District put forth the grievance in the following manner for solution and needful action.

The labour sardar of CWC & OSWC is demanding Rs. 10.74 p @ Qtl for unloading of CMR. OSCSC LTD. is paying us Rs. 2.00 @ Qtl as unloading charges . The labours are demanding Rs. 8.74 p excess unloading charges which we are unable to pay. They are not willing to unload the rice delivered by us ^{if} we are not paying unloading charges Rs. 10.74 p @ Qtl.

CSO office is forcing us to deliver 60% of CMR due at CWC & OSWC and 40% at RRC which is injustice . This may be changed to 40% to CWC & OSWC and 60% to RRC.

OSCSC LTD. has fixed 50% for FCI delivery. In FCI the labour and other unofficial cost for delivery of rice is excess than what Corporation pay us through bill. Hence , We may be allowed to deliver 30% CMR to FCI as done ⁱⁿ district like Balangir & Kalahandi.

Submitting our grievance for kind solution.
