Sub: Delivery of CMR to FCI by the millers of other districts – Submission of bill to FCI.

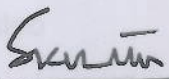
Sir,

With reference to the subject cited above, I am to say that in the KMS 2012-13 custom millers are allowed to participate in procurement of paddy in other districts. These millers are to deliver CMR out of paddy procured from other districts to FCI. The following guidelines/ instructions in this regard, are to be followed.

1. The District Manager of the district from where paddy is procured shall prefer bills to FCI for the CMR delivered by the custom miller of other districts. For example, the DM, OSCSC Jagatsinghpur shall prefer bills to FCI for the CMR delivered to FCI by the custom millers of Cuttack, out of paddy procured from Jagatsinghpur.
2. The procedure at 1 above shall be followed irrespective of the location of depot of FCI where CMR has been delivered. For example, the custom millers of Khurda may deliver CMR out of paddy procured from Jagatsinghpur at the depots of FCI within administrative control of Area Manger, FCI, Bhubaneswar (FSD Bhubaneswar, FSD Jatani etc.). In such case DM OSCSC Jagatsinghpur shall also prefer bills to FCI.

3. The bills shall be preferred by the District Manager, OSCSC to Area Manager FCI where the CMR has been delivered. For example, if the millers of Khurda have delivered CMR at FCI Jatni, out of paddy procured from Jagatsinghpur, the District Manager, Jagatsinghpur shall prefer bill to Area Manager FCI, Bhubaneswar.
4. The custom millers of other districts shall submit the documents like AC Note, weigh Check Memo etc at DM OSCSC of the district from where paddy has been procured for preferring bill to FCI.
5. On receipt of Provisional Economic Costing for the KMS 2012-13 from Govt. of India, the rate and other guidelines for preferring of bills would be communicated.
