Sub: Clarification on finalization of millers dues for KMS 2012-13

Sir,

All Odisha Rice Millers Association has represented that in some districts the custom millers are asked to obtain a certificate from RRC In charge to the effect "that the custom miller has delivered Qtl. ___ CMR at this RRC for KMS 2012-13 in conformity to prescribed specifications and without any quality complaints what so ever from any quarters. The CMR were delivered in New B.Twill Gunny bags confirming all the parameters of BIS Specification".

In this connection, I am to say that in the Corporation Head Office had issued a guideline/ bill format vide letter No. 515 dt.15.1.09, where in a certificate from RRC In charges confirming receipt of CMR of prescribed specification was required to be collected .

2. At present receipt of CMR from custom millers is documented by issue of Acceptance Note-cum-Analysis Report of CM Rice by RRC In-charge. The 2nd copy of such Acceptance Note is submitted at the District Manager office by the RRC In-charge .

3. Since RRC In-charges has already confirmed the receipt of CMR from the custom millers in the "Acceptance Note-cum-Analysis Report of CM Rice" further certificate from the RRC In-charge may not be required. However the District Office is to make following reconciliation of delivery of CMR as claimed by the miller as per the bill with the documents/records.

- i) The 2nd copy Acceptance Note-cum-Analysis Report of CM Rice submitted by RRC In-charge at district office with that of 1st copy of AC Note & bill Statement submitted by the millers.
- ii) Cross Check of the Mobile Reporting made by the custom miller.
- iii) Monthly Return submitted by the RRC In-charge with the bill statement.

In case of any dispute/overwriting /doubt about the claim of the miller, District Manager must get the figures reconfirmed from RRC In-charge.

4. As regards Certificate of RRC In-charges regarding quality of New B.Twill gunny bags supplied by the custom millers for packing of CMR in cases of shortage of Corporation supply gunny bags, a separate clarification is being issued.
