A copy of letter dtd.12.10.2015 issued by General Manager (purchase), Food Corporation of India, Head Quarters, New Delhi addressed to Joint Secretary(Policy & FCI) Government of India, new Delhi is enclosed, where in the matter regarding value cut by FCI on new gunny bags has been clarified. It has been clarified in the said letter that instructions issued by FCI in the year 2000 regarding value cut on new gunnies does not apply to new gunnies supplied by DGS &D for CMR packing. The said instructions are applicable only in case of new gunnies supplied by custom millers. It has also been mentioned in the said letter that where such value cut has been made by FCI, the matter needs to be reviewed in the light of current clarification.

Accordingly you are requested to instruct your Area Managers in different districts in Odisha not to impose any value cut in respect of DGS &D supplied gunny bags used in CMR packing by OSCSC and delivered in your Depots. You are also requested to take

steps for refund of the amount deducted earlier by your various area offices in Odisha on account of value cut on DGS &D supplied gunny bags. Action taken in the matter may kindly be intimated to this office at the earliest.
