Sub: Percentage of FCI delivery for the deficit procuring districts for the month February and March 2016.

Ref: Letter No. 23199 dt 07.12.2015 of FS & CW Deptt.

Sir.

This has the reference to the subject stated above regarding delivery of Rice of KMS 2015-16 to FCI by the custom millers. As per decision communicated by Government in FS & CW Deptt. vide letter No. 23199 dt 07.12.2015, the millers of 2nd phase districts shall deliver rice to FCI @100% / 80% in the month of January and February 2016. However, it is observed that delivery of rice by these districts has not been satisfactory for the following reasons.

- i. In coastal districts FCI is not giving sufficient delivery programmes. Collector, Cuttack in his letter 1046 dt 01.02.2016 has intimated that FCI has given delivery programme for two days only in one month resulting slow delivery of rice, besides other reasons. Copy of the letter of Collector is enclosed.
- FCI Depots continue to reject rice lots on the ground of quality/ weight of Gunny bags.
- 2. It is therefore proposed that the percentage of delivery of rice by the millers to FCI may be revised for the districts where the rice required for TPDS is not available and is being met on transfer from other districts. The following districts at present are being fed from other districts:- Mayurbhanj, Keonjhar, Jagatshinghpur, Kendrapara, Cuttack, Angul, Dhenkanal, Khurda, Kandhamal, Balasore, Sundargarh, Deogarh, Nuapada, Jajpur being deficit in rice. The custom millers of these districts may be directed to deliver rice @ 60% to FCI and balance 40% at RRC, for February & March 2016

preferably at OSWC/ CWC godowns. The vacant place available in godowns of these districts could be utilized for receiving rice from the millers. However such rice so received shall not be utilized under PDS at present. These districts shall be fed with rice on transfer from other districts. As such the evacuation of rice from surplus procuring districts shall be continued.

- 3. The surplus procuring districts such as Kalahandi, Sonepur, Nayagarh, Puri, Bhadrak, Boudh, Jagatsinghpur & Bolangir may be asked to receive rice from millers at the ratio of 75:25 to FCI & RRC respectively instead of 80:20 communicated earlier and this arrangement may continue till end of March 2016 till the closure of procurement.
- 4. In case of Raw Rice consuming districts namely Ganjam, Gajapati, Koraput, Rayagada, Nawarangpur & Malkangiri, the earlier decision of delivery of rice @ 70% to FCI and balance 30% at RRC may continue.
- Exact ratio of FCI and RRC delivery may be communicated to districts after 31.03.2016 taking into consideration of relevant factors such as total procurement and balance requirement under TPDS inside the state.

This is for kind approval and necessary communication to the concerned districts.
