Receipt of CMR in RRC

Sir,

I am to say that three numbers of samples were drawn out of the stocks delivered by the custom millers from RRC, Charampa during my visit to Bhadrak District on 06.06.2016. All the three samples have been analyzed at the Quality Control Cell of this Department as well as at the laboratory of Food Corporation of India, Regional Office, Bhubaneswar.

From both the analysis report, it is observed that stocks of CMR delivered by P.P Rice Mill and Khetrapal Rice Mill contains broken grains of 15.8% and 14.8% respectively as against the specification limit of 16% which is almost at the borderline of rejection. Similarly, stocks delivered by Khetrapal Rice Mill, Charampa Rice Mill and P.P Rice Mill contains damaged grains of 3.8%, 3.8% and 3.6% respectively as against the specification limit of 4.0% which are also almost at the borderlines of rejection.

Although the stocks delivered by three millers technically come under FAQ norms, these will not, however sustain its quality during further storage and may exceed the refractions as per standard parameters at the time of issue. Accepting such type of CMR under Decentralized Procurement System is tantamount to laxity in supervision of procurement operations by you.

You are therefore directed to explain under which circumstances such type of CMR are received in RRCs from the custom millers and why action shall not be taken against you for lack of proper supervision. Your explanation should reach the undersigned within 10(ten) days from the date of issue of this letter, failing which it shall be presumed that you have no explanation to offer and the matter shall be decided on its own merit.
