
Sub: Proceedings of State level RMC Secretaries Review Meeting held on 30.5.2016.

It is instructed to take necessary steps for compliance of the proceedings & furnish action taken report at the earliest.





Agenda-(11) Utilization of Godowns

For fully utilization of godowns the Member Secretary suggested that the OCAC may be requested to develop a software as regards the G.P.S locations of all the godowns so far constructed by RMCs, for uploading in the Net, so that the interested parties can have easy access. Prior to that each godowns are to be properly numbered. (Action - OSM Board)

The Member Secretary also suggested that as MARKFED is willing to hire the godowns for storage of fertilizers the same may be considered with a detailed agreement, so that damage caused to the godowns shall be taken care of by MARKFED.

All the RMC Secretaries are directed to submit the list of the vacant godowns with capacity immediately for submission to Govt. as desired by principal Secretary. (Action - RMC Secretaries)

Agenda-(12) Extension activities & formation FPO

Since Group Marketing is the key to success of the agricultural marketing, the Member Secretary instructed the Secretaries of RMC to engage the RMC staffs for formation of FPO in the RMC areas. If required the Odisha Rural lively Hood mission may be tied up for the formation of F.P.O & target of formation of Nos. 30 nos. of Group, within three months is given to each RMC which would be the parameter for judging the efficiency of the Secretaries for their further continuance in the sector which will be reviewed in the next meeting. Agenda-(13) Abolition of Check gates.

The Member Secretary categorically instructed all the Secretaries of RMC to abolish all the un-authorized Check gates if installed by the RMC within 7days as per the decision of the Hon'ble High Court & those gates with due permission from Govt. may be continued till issue of the notification by Govt. (Action - RMC Secretaries)
