Sub: Rates of incidentals for the KMS 2016-17 for settlement of bills of Custom Millers.

Sir,

Inviting a reference on the subject & letter stated above, I am to communicate the rates of incidentals payable to the custom millers for KMS 2016-17 as follows:-

- Transportation on Paddy: Rs.18/- per quintal for 1st 10 kms distance. For subsequent distance up to 40 Kms (i.e. for 11 Kms to 40 Kms) the rate is Rs.0.50 paisa per quintal per Km. If the distance from the Purchase Centre to Mills is more than 100 Kms, the rate of transportation charges for 11 Km and onwards is @ Rs.0.40 paisa per quintal per Km.
- Transportation on Rice: Rs.15/- per quintal for 1st 10 kms distance. For subsequent distance up to 40 Kms (i.e. for 11 Kms to 40 Kms) the rate is Rs.0.50 paisa per quintal per Km. and @ Rs.0.40 per quintal per KM for distances beyond 40 Kms i.e. 41 Kms onwards.
- 3. <u>Handling Charges on Rice</u>: The Handling charges on delivery rice is revised to Rs.4.00 p.q. and to Rs.6.00 p.q. for delivery of rice at RRC & FCI respectively from Rs.2.50 p.q./ Rs.5.00 p.q. in the KMS 2014-15.
- 4. <u>Custody & Maintenance Charges</u>: Custody & Maintenance Charges shall be paid for 3 months flat @ Rs.2.40 per quintal/ per month. The millers who have delivered entire CMR due by 30th September, 2017 shall be paid C & M Charges for 4 months @ Rs.2.40 p.q./p.m if the average storage period of paddy is 4 months or more. No C & M Charges shall be paid for the quantity of rice delivered after 30.09.2017.
- 5. Mandi Labour Charges:- Mandi Labour Charges shall be paid @ Rs.3.50 per quintal of paddy. Certificate from Purchase Officer of OSCSC in the format prescribed in Procurement Guideline are to be obtained.

- 6. <u>Milling charges</u>:- i) For Parboiled Rice Milling Rs.20.00 per quintal of paddy ii) For Raw Rice Milling Rs.10.00 per quintal of paddy.
- 7. Reimbursement of cost of new gunny bags supplied by millers:- Payment shall only be released to the custom millers if they have been asked to provide gunny bags for packing & delivery of CMR for KMS 2016-17 both at RRC and FCI due to short/delay in supply of gunny bales by OSCSC and Head Office has allowed the district to receive rice in gunny bags supplied by the millers. The rate of gunny bags will be communicated soon after receipt of CMR cost sheet from Govt. of India for KMS 2016-17.
- 8. **Gunny Depreciation:** Govt. of India has proposed for use of two new gunny bags and two old gunny bags for packing of paddy required for one quintal of rice. The decision of Govt. of India in this respect shall be followed. The rate of gunny depreciation will be communicated soon after receipt of Provisional CMR Cost Sheet for KMS 2016-17 from Govt. of India. Govt of India has been moved to reconsider the gunny depreciation.
- 9. <u>Insurance Premium</u>: Premium for Insurance of stock of paddy and rice at the premises of the miller shall be borne by the miller and Corporation on 50:50 basis. The rates of recovery from the miller will be communicated separately.

The rates for transportation charges on paddy, handling charges on rice, custody and maintenance charges and recovery of insurance premium have been revised for the KMS: 2016-17 compared to the rates of KMS: 2014-15. These revised rates shall only be applicable for the millers who have delivered entire CMR due of KMS 2016-17 by 30.09.2017. The millers who fail to deliver entire CMR by 30.09.2017, shall be paid at the pre-revised rates for the 4 incidentals i.e. rates communicated for the KMS 2014-15.
