Sub: Delivery of paddy to custom millers during KMS:2016-17.

Letter No.1198/MD dt.03.11.2016-Operational Guidelines for KMS:

2016-17.

Sir,

Inviting a reference to the letter on the subject cited above, I am to say that procurement of paddy for KMS:2016-17 has already been started or will be strated in your district shortly. Provision has been made for regulating allocation of paddy to custom millers through execution of system generated documents namely Miller Authority Slip (MAS) & Society Authority Slip (SAS) during current KMS. The Para 23 of Operational Guidelines for KMS:2016-17 clearly envisages the modalities of delivery of paddy to custom millers and maintenance of MAS & SAS.

- 2) Paddy as per eligibility of miller shall be delivered to the custom millers strictly as per Miller Authority Slip (MAS).
- Miller Authority Slip (MAS) as per security deposit and milling capacity will be 3) generated from the system with the name of the societies with paddy to be lifted from them which will be issued by CSO-cum-District Manager.
- The admissible quantity of paddy for a miller shall be decided basing on entitlement ratio, security deposit furnished and milling capacity as specified in the MAS.
- 5) The DCCB & PACS shall ensure that the miller is not delivered paddy in excess of the quantity as indicated in MAS.
- Each society will have one society Authority Slip (SAS) based on MAS of all millers tagged to it which will indicate the quantity of paddy to be lifted by each miller.
- 7) The system generated MAS & SAS will be referred in all accounting / monitoring work in connection with paddy procurement operations.

8) Societies shall strictly maintain SAS document during delivery of paddy to tagged custom millers otherwise their commission will not be released. Custom millers shall maintain MAS for release of their bill amount dues etc. as per provisions in Para 54.5 of Operational Guidelines for KMS:2016-17.

It is therefore requested to ensure delivery of paddy to custom millers on strict execution of MAS & SAS.

Any deviation in the matter shall be viewed seriously.
