Sub:- Engagement of Handling Contractor for mandi handling operation at Paddy Purchase Centres (PPCs).

Sir,

I am to say that it has been decided to engage Handling Contractors in all paddy purchase centres run by PACS/LAMPCS, WSHG, Pani Panchayat and OSCSC run centres to perform mandi handling operations in KMS 2016-17. Such handling contractors shall be appointed through open tender process. This would bring in transparency to procurement operation. It may be informed you that such system of engagement of handling contractors was implemented successfully in Kalahandi district in KMS 2015-16.

2. The sample tender document for inviting tenders from the interested persons is available in the www.oscsc.in website. This may be downloaded for reference and record. Another copy of the tender document is also sent in word file by mail.
3. The district name and other information are required to be filled in the tender document and tender call notice. This is to be done carefully to ensure that gaps are properly filled in.

5. The sample tender call notice is also available in the Corporation website www.oscsc.in. The duly filled in tender notice is to be published in 02 Odia dailies.


I am to request to complete the tender process as per the date line mentioned below, so that handling contractor can be placed at the PPCs from 1st January, 2017 for mandi handling operations.


