Sub: Direct Fund Transfer of MSP to the accounts of farmers--
miscellaneous issues and corrective steps, regarding.

Madam / Sir,

I am to say that for procurement of Kharif paddy during KMS 2016-17, arrangement has already been made to transfer MSP towards paddy procured from the farmers direct to their bank accounts from a central paddy procurement account maintained by Odisha State Cooperative Bank (OSCB) on behalf of Odisha State Civil Supplies Corporation (OSCSC). Other State agencies have also been advised to open such an account centrally with OSCB.

The societies are supposed to submit payment advice at the end of the day for all farmers who have sold their paddy on that day. Usually, disbursement of MSP to farmers is done on the same day or maximum within next 2 days. But, in case of farmers having **wrong account details** in their record, the payment request for the farmer gets rejected by the system. District administration can find the updated '**List of Error Transaction**' in Paddy Procurement Automation System (P-PAS) module under menu link '**Report on Farmer**'.


The CSO is required to put an earnest effort to rectify the errors in the account details in consultation with bank branch concerned and the PACS concerned. Once the farmer's records in Food Odisha Portal are rectified by the CSO with correct bank account details, the PACS shall be intimated to draw correct farmers' record from Food Odisha Portal and prepare payment advice of those farmers once again for processing. This should be treated as urgent and be done on a daily basis to ensure quick payment to farmers.

It is observed that many societies are not preparing the payment advice on a daily basis. They are also not uploading the purchase data to central server on a daily basis. CSOs and DRCS/ ARCS are required to ensure that the societies must upload purchase data and prepare payment advice for farmers on a daily basis without fail.

It is also observed that the millers are not providing acknowledgement immediately through **mobile application** on receipt of paddy. CSOs need to impress upon the millers to provide acknowledgement immediately on receipt of paddy.

You are therefore requested to kindly direct the CSOs and DRCS/ ARCS to impress upon the societies and millers to take necessary steps for seamless implementation of Direct Fund Transfer to the accounts of farmers.






