**Sub:- Guidelines for participation of custom millers in Rabi Season of KMS: 2016-17.**

Sir,

With reference to the subject cited above, I am to say that guidelines for participation of custom millers in Rabi season of KMS 2016-17 have been prepared.


Following conditions shall be followed while engaging custom millers for participation in Rabi Season of KMS: 2016-17.

1. Millers of Balasore, Cuttack, Jharsuguda, Jajpur, Kandhamal, Kendrapara, Khurda, Mayurbhanj & Puri who have delivered 50% or more of the CMR due for the paddy procured in Kharif season as on the date of commencement of procurement in the district will be allowed to participate in Rabi procurement operation.  
In case of the millers of Jajpur, Khordha & Puri who have participated in Bhadrak & Jagatsinghpur, the percentage is to be calculated for the paddy received and rice delivered on account of both of the districts taken together.
2. The millers of all other districts namely Bargarh, Bolangir, Boudh, Kalahandi, Koraput, Nabarangapur, Nuapada, Rayagada, Sambalpur and Sonepur who have delivered 75% or more of the CMR due out of paddy received from own district and from other district if any taken together will be allowed to participate in Rabi procurement operation. This percentage of delivery shall be calculated as on the date of commencement of procurement in the district.
3. The millers willing to participate in Rabi procurement operation in other districts can be allowed if they have delivered at least 75% of CMR due as on 30.04.2017.
4. Apart from Security Deposit, Post Dated Cheques (PDCs) shall be obtained from the millers for the value of paddy delivered beyond security deposit as per detail procedure communicated for Kharif.

5. Milling capacity per annum (240 days) is to be treated as upper limit of total paddy to be delivered by all State Agencies to a miller during the KMS (both Kharif & Rabi).
6. The number of PACS/Societies during procurement would be less in Rabi than that of Kharif. Hence, the tagging of millers to PACS may be reworked to minimize the transportation cost of paddy from mandis to mills.
7. Delivery of paddy to the millers should be made through MAS i.e. as per security deposit, milling capacity and CMR delivered with reference to Kharif paddy.
8. The millers who have completed delivery of CMR of KMS 2015-16 after 31.12.2016 will be given paddy @ 3 times the security deposit subject to milling capacity up to September, 2017.
9. Raw rice mills in boiled rice consuming districts and vice versa should not be allowed to participate in Rabi procurement.

The above guidelines shall be followed scrupulously.


