Joint Director(HS)-cum-Deputy Secretary to Govt. Proceedings of the meeting held on 25.07.2017 at 4.30 PM in the Chamber of Principal Secretary to Govt., FS & CW Department on entitlements of mandi labour charges and modalities for claim bills

The meeting on Mandi Handling Operation was held under the chairmanship of Principal Secretary to Government, FS & CW Department.

The members present is at Annexure-I.

Discussion was held about Mandi Handling operations at PPCs and payment of Mandi Handling charges with reference to letters issued vide No. 802 dated 16.01.2014 of FS & CW Department and No.9059 dated 01.06.2017 of OSCSC H.O.

Registrar of Co-operative Societies submitted that PACS/LAMPCS (societies, in short) have been extending their services for successful paddy procurement operations in the State. So the restriction imposed for deduction of 50% commission due from the entitlement of societies concerned for their inability to do mandi handling operations at PPCs may be withdrawn.

After threadbare discussion about the roles of different stakeholders in paddy procurement operations and ground realities in the field, following decisions were taken.

- 1.1 Mandi Handling Operations may be performed either by the society or custom miller or any other agency partly or fully in the following manner.
- 1.2 Where Societies perform all Mandi Handling Operations including loading of paddy to the vehicles of miller, such societies shall be paid entire Mandi Handling charges.
- 1.3. Where societies are unable to perform Mandi handling operations at purchase centres, custom millers may be entrusted with such operations. In such an event, the custom millers shall be paid entire Mandi Handling charges as decided by OSCSC/Govt.
- 1.4. Where Societies perform handling operations in part i.e. all operations excluding loading to vehicles of millers, Mandi handling charges shall be paid proportionately to the society and the custom miller as decided by Govt./OSCSC based on provisional economic costing issued by Gol.

- 1.5. Before the commencement of each procurement season, DLPC under the Chairmanship of Collector of the district shall finalise society-wise status of Mandi handling operations of the concerned district participating in paddy procurement operations. A comprehensive proposal in this regard shall be placed before the Committee by the DRCS/ARCS of the district to facilitate a decision by such Committee.
- 2. The societies which have opted not to engage in Mandi handling operations shall also be entitled to commission charges in full as approved by Government of India.
- 3. Based on the decision of DLPC, Mandi handling charges shall be paid to the agency which may be either the society concerned or the custom miller who is actually carrying out the operations.
- 4. Proper Records and Registers like Muster Rolls for workers engaged in PPCs shall be kept by the agency/custom miller who has performed mandi handling operations.
- Commission to societies is to be paid centrally by the OSCSC Head Office. OSCB shall raise bill for the paddy procured through societies district-wise duly reconciled with P-PAS figures. Registrar, Cooperative Societies, Odisha may forward the bill to Managing Director, OSCSC for necessary payment.

The meeting ended with a vote of thanks to the chair.
