Sub: Allotment of Tentative Target(1st phase) in terms of rice for the KMS 2017-18(Kharif).

Madam/Sir,

I am directed to say that procurement of paddy (Kharif Crop) is going to start from 1.11.2017.

In order to facilitate immediate procurement, it has been decided by Government to distribute target, in the $\mathbf{1}^{st}$ **phase**, in terms of rice(as per statement enclosed) for the KMS 2017-18 (Kharif) to procure equivalent paddy in your districts.

These targets should immediately be redistributed among the participating societies and eligible millers tagged to them to lift the paddy procured from registered farmers in one go. The target to the millers who are yet to deliver CMR may be allotted but not released till further orders. The target among the millers should be allotted on the basis of their milling capacity and the security deposit.

It should be ensured that no paddy procured should remain unlifted from the PPCs(mandies) at the end of the day. Millers' tagging should accordingly be ensured.

Requests for additional targets from districts may be sent well in advance.

You are therefore requested to take appropriate action at your level immediately.
