Sub:Request for urgent revision of usage charges of gunny fixed for packing of procured paddy for KMS 2017-18.

Sir,

I am directed to refer to your D.O letter no. 20112/SFS&CW/FSCW-QC-MISC-0009-2016 dated 10.10.2017 on the above mentioned subject wherein it has been requested to convene a meeting of State Govt of Odisha, local FCI regional head and officials concerned of GoI to decide a realistic and workable rate of old bags for paddy packing for smooth paddy procurement operations in the State.

- In context of this, it is mentioned that usage charges for packaging of procured paddy for KMS 2017-18 have been revised upto Rs 7.32/bag vide this office letter even no dated 5/10/2017 subject to conditions specified therein as per recommendations of FCI Hqrs, New Delhi, being the specialist agency in procurement operations. As per FCI's recommendations, the net cost of one bag Rs 7.32 considered as usage charges has been arrived at by taking into account the average of minimum rate of multiple used gunnies in various States (excluding Haryana) as Rs.12/- and average realizable value of unserviceable gunny bags as Rs.4.68/-. It may kindly be appreciated that above usage charges has been revised with detailed consultations and as per the recommendations of FCI Hqrs
- In view of above, State Govt is requested to make arrangement of 3. jute bags as per revised guidelines and extend support to GoI in streamlining the packaging material arrangement so that procurement operations are not affected.
