Madam/Sir,

I am directed to say that after careful consideration of advance estimates of productivity of paddy(Rabi Crop) during the current season, procurement rates during previous seasons, feedback received from various sources and other relevant inputs, Government have been pleased to decide that paddy will be procured @ 26 quintals per acre from Bargarh, Sambalpur and Subarnapur i.e. districts coming under Hirakud Command Area and @ 24 quintals per acre from all other Rabi paddy procuring districts during the upcoming Rabi procurement season from 1.5.2018 to 30.6.2018.

While calculating the marketable surplus of the registered farmer there would be no deduction towards food grain needs of the farmer's family from the surplus calculated as above.

These rates are being updated in the Farmer Registration module and P-PAS application at the backend.
