Sub: Allotment of target (1<sup>st</sup> phase) in terms of rice for procurement of paddy(Kharif Crop) during KMS 2018-19 in favour of OSCSC.

Madam/Sir,

I am directed to say that procurement of paddy (Kharif Crop) is going to start from 1.11.2018.

- 2. In order to facilitate procurement, it has been decided by the Department to distribute target, in the  $\mathbf{1}^{\text{st}}$  **phase**, in favour of OSCSC in terms of rice(as per statement enclosed) to procure equivalent paddy in your district.
- 3. The entire target should be redistributed among the participating societies and eligible millers tagged to them in one go. The target among the millers should be allotted on the basis of their milling capacity and the security deposit.
- 4. No target should remain undistributed and kept pending at district office.
- 5. It should be ensured that no paddy procured should remain unlifted from the PPCs (mandies) at the end of the day. Millers' tagging to the PPCs should accordingly be ensured.
- 6. Request for additional target from district may be sent well in advance.
- 7. You are therefore requested to kindly take appropriate action at your level immediately.
