Sub: Regarding payment of Mandi Handling Charges for the KMS:2018-19.

Ref:- 1. This Office letter No.13244 dt.04.08.2017- Payment of Mandi Handling Operation at PPCs.

Sir,

Inviting a reference to the subject cited above, I am to say that, Para-29 of the Operational Guidelines for KMS: 2018-19 envisages that before commencement of procurement season, DLPC is to decide who will take up mandi handling operation at PPCs i.e. Society and/or Miller partly or fully for paddy procurement. Detailed instructions on mandi handling operation at PPCs and modalities on payment of mandi handling charges have been communicated vide this Office letter No.13244 dt.04.08.2017.

However it is observed from the proceeding of the DLPC meeting of your district held on 12.10.2018 that no such decision has been taken regarding the agency (Society/Custom Miller) to carry out the mandi handling operation in the current KMS.

Mandi handling operation being key to ensuring smooth procurement, it is to be discussed and resolved in DLPC meeting keeping in view capacity and willingness of either party. Further this has to be district specific in accordance with varying situations. The districts who have left the issue undecided in DLPC meeting already held should convene urgent meeting of DLPC and make a clear resolution on it to avoid ambiguity and indecision. If DLPC can not meet at short notice, Collector of the district may pass a reasoned and express order assigning work either to PACS or Millers which will be ratified by the DLPC, concerned
