Sub:- Reimbursement of transportation charges to the custom millers for lifting of paddy from PPC/Mandi to mill and for delivery of CMR at RRC/FSD for the KMS 2019-20

Ref:- This office letter No. 5506 dt.22.04.2020

Sir,

Inviting a reference on the subject cited above. I am to say that the rates of transportation charges for 1st eight Kilometers payable to the custom millers for lifting of paddy from PPC and delivery of CMR at RRC/FSD for KMS 2019-20 was communicated to you vide this office letter No. 5506 dt.22.04.2020. It was further instructed to invite e-tenders for discovery of rates for transportation of paddy and rice. No district except Sambalpur and Jharsuguda could finalize the rate through tender process. As per the guidelines, Govt. of India shall reimburse the transportation charges at the rate discovered through tender process only.

In view of above, it has been decided in the 190th meeting of the Board of Directors of OSCSC that pending discovery of the rates through tender process the transportation charges for the distance beyond 8 kilometers may be reimbursed to the custom millers **provisionally** at the following rates. All the districts have been asked vide this office letter No.11489 dt.16.09.2020 to invite e-tender for selection of transport contractors for KMS 2020-21. The final rates for KMS 2019-20 will be decided after the rates are discovered for KMS 2020-21.

The District Managers shall ensure that distance from mandi to mills and from mills to RRC/FSD are approved by the Collector as per guidelines issued from this office earlier. Off late it has been noticed that there has been audit objections for payment of extra transportation charges to the custom millers on account of distance factor. This has to be taken care off.
