Sub: Utilization of HDPE/PP bags for packing of CMR in KMS 2020-21.

Sir,

Inviting a reference on the above subject, I am to say that due to short supply of jute bags by Jute Commissioner of India, Govt. of India has allowed for procurement of 25000 HDPE/PP bags for packing of CMR in KMS 2020-21. As per instruction of Govt. of India, the CMR packed in HDPE/PP bags are to be utilized on priority to avoid detoriation/ damage of food grains. Mean while Corporation has already procured HDPE/PP bags and delivered at the designated depot of the district. The UV testing of 1st lot sample bags received from districts is being done through CIPET and test report has been received from CIPET.

It has been decided to utilize these tested HDPE/PP bags for packing and delivery of CMR by custom millers. In this connection following guidelines are issued for compliance.

- The custom millers after packing of CMR in HDPE/PP bags shall deliver the rice immediately at the RRC. The millers shall ensure & plan their delivery schedule accordingly, so that the rice stock packed in HDPE/PP bags is delivered at RRC preferably within two days of packing.
- 2. The CMR packed in HDPE/PP bags shall only be received at those RRC where there is possibility of utilization of these rice bags immediately after receipt from custom millers. However, in no case the stock shall remain in the RRC more than 10 days. Accordingly the district manager shall plan delivery of CMR by the miller at RRC.
- 3. A separate stock account of HDPE/PP bags shall be maintained miller wise and KMS wise.

- In case of any quality complain on HDPE/PP bags the same must be intimated to this
 office, indicating the supplier details with lot No, Bale no, Invoice No & quality inspection
 report.
- 5. The districts namely Baragarh, Bolangir, Boudh, Jharsuguda, Sambalpur, Sonepur & Sundargarh who have received HDPE/PP bags supplied by M/s Satyendra Packaging Limited with bale no. 01 to 2500 are allowed to utilize those bags for packing and delivery of CMR. As soon as test report for other lots are received from CIPET it will be communicated to the districts concerned for utilization of those HDPP/PP bags.
