Points for discussions with Managing Director, Oscsc Ltd, Bhubaneswar.

- 1. **Unprecedented delay in payment of dues of Custom Millers**. Such delay has never happened in the history of OSCSC.
- 2. Release of dues of millers for KMS 2013-14 who have already completed delivery of CMR. **Payment is not released by concerned district office on the ground that sufficient funds are not available** with Oscsc.
- 3. Norms for payment of current dues after delivery of 25%, 50% and 75% are not followed in spite of clear stipulation in the agreement. Clear instructions may be issued.
- 4. There is widespread confusion regarding payment of TC and recertification of distance. Distance already approved by Collector may be followed except in case of major variation, if any. In future, certification of distance may be made part of procurement preparedness at the beginning of procurement season as a matter of policy to avoid delay in release of transport charges.
- 5. Finalization of dues of every miller for KMS 2014-15 upto 31.3.15 in view of provision to be made for close of financial year 2014-15 and calculation of TDS etc. This is a compulsory requirement under Income Tax Act.
- 6. Payment of transport charges on paddy lifted by miller from other district may be paid as per usual rates. Instead of keeping suspense over the rates, transparency needs to be maintained by defining the rates of transportation as soon as a miller is allowed to participate in other district to avoid any possible undue favor or loss to the Custom Miller.
- 7. Cost of New Gunny Bags worth more than Rs.1.5 crore is yet to be reimburshed to Millers of Ganjam for KMS 2013-14. In stead of appreciating their effort in speeding up rice delivery, they are being penalized for helping the Corporation when it was not able to supply gunny bags in time.

- 8. There is no initiative in ensuring **timely refund of old security deposits**. In spite of repeated assurances at different times by higher officials of the Oscsc, the matter remains un-resolved. Immediate steps may be taken for refund of all old security deposits of Rs.25,000/- as well as 1.5 lakhs for 2009-10 and earlier years. The pending case of Gajapati district is a point to be noted.
- 9. Settlement of claims submitted at Head Office as well as respective district offices during the observance of "Pending Claim Settlement Week" in 2nd week of November, 2014 vide Oscsc Letter No.19994 Dt.30.10.2014. A sum up of all the claims may be made for proper follow up and early settlement.
- 10. The incidence of delivery of paddy to millers in excess of security deposit in some cases may be due to **failure of the district administration in implementing "Cap Storage"** inspite of Government instructions in this regard.
- 11. Any other matter.
