Sub: Milling charges and other procurement incidentals to be paid to the custom millers for the KMS 2012-13.

Ref: This office letter (i) No.Acct/Com/DPC-I/2012-13/ 5972 dated 21.03.2013 (ii) No.6084 dated.21.03.2013

Sir.

Inviting a reference to the subject cited above, I am to say that instruction was issued vide letter No.5972 dated 21.03.2013 for payment of milling charges, transportation charges and handling charges on rice for the KMS 2012-13. Subsequently another letter No.6084 dated 21.03.2013 was issued revising rates for milling charges. There is still some mistakes in the letter No.5972 dated 21.03.2013. Hence I am directed to say that the entire instructions issued in the letter No. 5972 dated 21.03.2013 is revised as follows.

Milling charges	Rs.20/- per qtl. of equivalent paddy for delivery of common para boiled rice and Rs.10/- per qtl of equivalent paddy for delivery of common raw rice.
Transportation     Charges on Paddy     & Rice	<ul> <li>i. Paddy – Rs.7/- per qtl. for first 10 kms and @ Rs.0.35 per qtl/ km for subsequent distance covered to transport paddy from purchase centre to mill point.</li> <li>ii. Rice – Rs.7/- per qtl. for first 10 kms and @ Rs.0.35 per qtl/ km for subsequent distance covered to transport and deliver CMR from mill point to RRC/ FCI.</li> </ul>

3. Handling	i. Delivery at RRC of OSCSC - Rs 2 per qtl of rice where the
Charges on	miller has performed all the operation to unloading the stock
Rice	from vehicle and stacking inside the godown.
	ii. Rs 4 per qlt of rice for CMR delivered to FCI.

The miller shall be paid above charges for the quantity of CMR delivered. As provided at clause No.48 of Procurement guidelines of KMs 2012-13 issued vide Letter No. 20232 Dt. 02.11.2012 the bills of the custom millers who have delivered at least 25% of CMR due of KMs 2012-13 shall only be paid.

The instructions issued vide letter No. 5972 dated 21.03.2013 and No.6084 dated .21.03.2013 shall not be acted upon.
