Whereas for maintaining the supply of rice and for securing its equitable distribution and availability at fair prices in the State of Odisha, the State Government had made the Odisha Rice and Paddy Procurement (Levy) and Restriction on Sale and Movement Order, 2013, which is published in the extraordinary issue of the Odisha Gazette No.2115 dated the 23<sup>rd</sup> October, 2013;

And whereas, the Central Government have issued direction to all State Governments in their letter No.F.No.6(1)/2007-Py.III dated the 20th February, 2015 that no State Government shall impose any levy on rice from the Millers with effect from 1st October, 2015 and all the State Governments where the percentage of levy imposed is upto 25% at present on standing basis, shall take action to, immediately, amend their levy order to ensure that no levy is imposed from 1st October, 2015 onwards;

And whereas, the Central Government is providing its advance concurrence for such amendments in levy order of the State;

And whereas, the earlier concurrence given by the Central Government with regard to levy order for imposition of levy upto 25% has been withdrawn with effect from 01.10.2015:

And whereas, the State Government are of the opinion that it is necessary and expedient to withdraw the said order to ensure payment of remunerative prices to farmers at Minimum Support Price (MSP) or above and streamline outreach of procurement system to the farmgate for their better coverage.

Now, therefore, in exercise of the power conferred by Section-3 of the Essential Commodities Act, 1955 (Act 10 of 1955) read with the notification of the Government of India in the erstwhile Ministry of Agriculture and Irrigation (Department of Food) GSR 800, dated the 9<sup>th</sup> June, 1978, published in the Gazette of India, Part-II, Section-3, sub-section (1) dated the 9<sup>th</sup> June, 1978, the State Government do hereby rescind the Odisha Rice and Paddy Procurement (Levy) and Restriction on Sale and Movement Order, 2013 with effect from the 1<sup>st</sup> day of October, 2015.
