Sir,

Enclosed please find herewith the communications under reference on the aforesaid subject.

The transportation rate applicable for CMR delivery by the State Govt/Agencies at the rate of Rs. 0.50 per quintal per KM upto 40 KMs and Rs. 0.40 per quintal per KM beyond 40 KMs upto 100 KMs for KMS 2012-13 has been approved by ED (East), FCI, Zonal Office, Kolkata vide letter No.Proc.5 (1)/Odisha Transportation Charges/2013 dated 22.07.2013 as per the recommendation of the committee consisting of GM (R), FCI, RO, Odisha, DGM (Finance), FCI, RO, Odisha, DGM (Finance), OSCSC Ltd. and Addl. Secretary , FS &CW Department, Govt. of Odisha.

The above transportation rate is applicable for (a) FCI CMR from zero KMs to 100 KMs, (b) Paddy Transportation from purchase centre/ Mandi to Mill from zero KMs to 100 KMs and (c) Levy rice transportation beyond 8 KMs to 100 KMs subject to following terms and conditions.

1. An undertaking be taken from the State Government /Agencies/Millers that these payments are deemed to be provisional and they shall finally abide by and accept the transportation charges as and when finalized by the Tariff Commission.

2. The payment of transportation charges shall be subject to the condition that the State Government/Agencies/Millers shall furnish a certificate to the effect that the transportation charges have been actually incurred.

3. The payment shall be payable on the basis of FCI rate or State Govt. rate whichever is lower.

4. Payment for distance beyond 40 KMs shall only be made where no godowns are available either physically or in terms of space within 40 KMs.

5. It should be ensured that the transportation is restricted to minimum necessary distance.

6. The purchase centre/ mandi and the mill need to be distinct and separate so as to require any transportation.

7. There should be due evidence that transportation charges of paddy has been created for such distance.
