Sub: Delivery of CMR to FCI by the custom millers for KMS: 2011-12 and participation in paddy procurement operations in KMS: 2012-13.

Ref: Operational Guidelines for KMS: 2012-13 (Page-50, para-16.3).

Sir.

Inviting reference to the above, I am to say that as per para-16.3 of Operational Guidelines for KMS: 2012-13 the custom millers who have delivered CMR to FCI less than the district average of FCI delivery during KMS: 2011-12 shall not be considered for participation in KMS: 2012-13. However in case a miller has delivered 100% CMR or sufficient CMR is not available with him to bring his delivery to FCI at par with the district average, shall be allowed to participate with the condition that he will deliver the short fall to FCI in the beginning of KMS: 2012-13.

The delivery of CMR against the short fall of KMS: 2011-12 shall not be counted for the target fixed for KMS: 2012-13 i.e. 50% / 20% of CMR due for delivery to FCI.

- It has come to the notice of the undersigned that the above provisions of the guidelines are not followed meticulously in your district. Though some millers are delivering CMR to FCI regularly, there are instances of less delivery of CMR by some other millers to FCI.
- The millers who deliver less quantity or don't deliver CMR to FCI, take advantage
  of the situation and other millers are constrained to complain for such
  discrimination.

It is therefore requested to ensure that all the millers of your district shall deliver CMR to FCI as per the target fixed during the current KMS: 2012-13 in addition to the backlog of KMS: 2011-12. Accordingly District Manager shall ensure proportionate issue of Delivery Certificate to the custom millers for delivery of rice at RRCs and FCI.

Action taken in the matter shall be reported immediately.
